#### TITLE

This RESOLUTION shall be known and may be cited as the Cooperative Pricing Resolution of the Township of Edison

#### **AUTHORITY**

Pursuant to the provisions of *N.J.S.A.* 40A:11-11(5), the Mayor or his designee is hereby authorized to enter into a Cooperative Pricing Agreement with the Lead Agency.

#### **CONTRACTING UNIT**

The Lead Agency shall be responsible for complying with the provisions of the *Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.)* and all other provisions of the revised statutes of the State of New Jersey.

#### **EFFECTIVE DATE**

This resolution shall take effect immediately upon passage.

**WHEREAS,** bids were received by the Township of Edison on November 28, 2018 for Public Bid No. 18-01-18-Promotional Items, Trophies and Awards; and

**WHEREAS,** J.J. RYAN INC., 242 Amboy Avenue, Woodbridge, NJ 07095 submitted the lowest legally responsible bid for various items of the bid as listed on the spreadsheet; and

**WHEREAS**, the initial contract shall be for one (1) year from execution of the contract with options to renew for two (2) one (1) year renewals at the sole discretion of the Township at the same prices, conditions, requirements and terms of the contract, subject to and contingent upon appropriation of sufficient funds each renewal year; and

**WHEREAS,** the total amount of the first year and any succeeding renewal year shall not exceed \$3,000.00, and cannot be encumbered at this time; and

**WHEREAS,** pursuant to N.J.A.C. 5:30-11.10 funds for Open-End Contracts shall be committed at the time an order is placed and shall not exceed the unit price; and

WHEREAS, no amount shall be chargeable or certified until such time as goods or services are ordered or otherwise called for. Prior to incurring the liability by placing the order, the certification of available funds shall be made by the Chief Financial Officer or Certifying Financial Officer. WHEREAS, the Township Council of the Township has determined that, due to and under the circumstances noted above, it is in its best interests, those of Township residents, and those of the aforesaid federal employees resident within the Township, to extend the statutory deadline for the payment of First Quarter 2019 *ad valorem* real estate taxes, including the statutory, interest-free Grace Period for such payments, for all such federal employees resident within the Township of Edison, consistent with actions, if taken, by the State of New Jersey with respect to the payment of such taxes in light of the federal government shutdown; and
