ORDINANCE 0.2130-2021

EXPLANATION: An Ordinance amending the Township Code Chapter 37, "Zoning," Schedule A, "Schedule of Area, Yard and Building Requirements," to increase the minimum lot requirements for the G-C Golf Course – Natural Preservation District.

WHEREAS, the Township of Edison (the "**Township**") is a public body corporate and politic of the State of New Jersey; and

WHEREAS, the Township Code of General Ordinances (the "Code") provides rules, regulations and standards to conserve the value of property and encourage the most appropriate use of land in the Township, pursuant to Chapter 37 of the Code; and

WHEREAS, the Township desires to amend Chapter 37, Schedule A of the Code, entitled "Schedule of Area, Yard and Building Requirements," to increase the minimum lot requirements for the G-C Golf Course – Natural Preservation District, as referenced in Chapter 37-46.5 therein; and

WHEREAS, prior to the Municipal Council hearing on the adoption of this Ordinance, it shall be referred to the Township Planning Board, as required by *N.J.S.A.* 40:55D-64 and *N.J.S.A.* 40:55D-26 of the Municipal Land Use Law (the "**MLUL**"); and

WHEREAS, the Municipal Council of the Township ("**Municipal Council**") has determined to amend Subchapter 37-30.2 of the Code to read as follows (additions are <u>underlined</u> and deletions are in [brackets]):

... [NOTE to Codifier. Existing text not appearing herein has been deleted solely for brevity. NO CHANGE] ...

Schedule A Schedule of Area, Yard and Building Requirements Attached as Exhibit A

... [NOTE to Codifier. Existing text not appearing herein has been deleted solely for brevity. NO CHANGE] ...

NOW, THEREFORE, BE IT ORDAINED by the Municipal Council of the Township of Edison, Middlesex County, State of New Jersey, as follows:

1. The aforementioned recitals are incorporated herein as though fully set forth at length.

2. The Municipal Council hereby amends Chapter 37, Schedule A, "Schedule of Area, Yard and Building Requirements," as set forth herein, and more specifically, attached as <u>Exhibit</u> <u>A</u> hereto.

3. Upon introduction and prior to the Municipal Council hearing on adoption, the Township Clerk is hereby directed to provide a copy of the within Ordinance to the Township Planning Board for review in accordance with the MLUL.

4. It is the intent of the Municipal Council to incorporate the additions, amendments and/or supplements contained in this Ordinance into the Code. All of the remaining provisions in Chapter 37 of the Code shall remain unchanged and have full force and legal effect.

5. If any section, paragraph, subdivision, clause, sentence, phrase or provision of this Ordinance is declared unconstitutional or invalid by a court of competent jurisdiction, such decision shall not affect the remaining portions of this Ordinance.

6. A copy of this Ordinance shall be available for public inspection at the offices of the Township Clerk.

7. This Ordinance shall take effect after twenty (20) days of its final passage by the Municipal Council, upon approval by the Mayor and publication as required by law.

ORDINANCE 0.2131-2021

EXPLANATION: An Ordinance authorizing the acquisition of certain property located at 1681 Woodland Avenue in the Township, shown on the Township's Tax Maps as a portion of Block 415, Lot 5-B-1.

WHEREAS, Thomas and Karen Shea (the "**Owner**") own the property shown on the Township of Edison's (the "**Township**") Tax Maps as Block 415, Lot 5-B-1, located at 1681 Woodland Avenue and consisting of approximately 17.03 acres (the "**Property**"); and

WHEREAS, the Owner and the County of Middlesex (the "**County**") entered into an Agreement to Purchase and Sell Real Estate, dated October 1, 2021 (the "**Agreement**"), acopy of which is attached hereto as <u>Exhibit A</u>, whereby the County agreed to acquire approximately 7.49 acres of the Property (the "**Acquisition Parcels**"); and

WHEREAS, paragraph 26 of the Agreement permits the County to assign the Agreement to the Township; and

WHEREAS, pursuant to *N.J.S.A.* 40A:12-5, the Township may acquire any real property or capital improvement; and

WHEREAS, the Township desires to accept assignment of the Agreement from the County and acquire the Acquisition Parcels from the Owner for a purchase price of \$2,400,000.00, pursuant to the terms of the Assignment of Agreement to Purchase and Sell Real Estate, a copy of which is attached hereto as <u>Exhibit B</u> (the "Assignment"); and

WHEREAS, pursuant to the terms of the Assignment and the Conservation Restriction Agreement between the Township and the County, a copy of which is attached hereto as <u>Exhibit</u> \underline{C} (the "**Conservation Restriction**"), the County, pursuant to *N.J.S.A.* 40:12-15.6, agrees to donate to the Township an amount of \$2,400,000.00 to purchase the Acquisition Parcels from the Owner on the condition that the Acquisition Parcels remain open space and that the natural features of that open space be preserved and used only for active or passive recreation; and

WHEREAS, in order to set forth the terms and conditions under which the Township, the County and the Owner will carry out their respective obligations with respect to the transaction described herein, the Township further desires to authorize the execution of any documents necessary to effectuate the acquisition.

NOW THEREFORE, BE IT ORDAINED by the Municipal Council of the Township of Edison, County of Middlesex, New Jersey that:

1. The aforementioned recitals are incorporated herein as though fully set forth at length.

2. The Township, pursuant to the Conservation Agreement, is authorized to accept donation of the purchase price from the County and acquire the Acquisition Parcels from the Owner for \$2,400,000.00, which price is hereby deemed reasonable.

3. The Mayor is hereby authorized to execute the Assignment and any and all documents necessary to effectuate the acquisition of the Acquisition Parcels from the Owner, upon such terms and conditions as are set forth herein.

4. The Township is further authorized to take all steps necessary for the conduct of due diligence and closing of title for the transaction described herein.

5. The Township Clerk is hereby directed to publish this Ordinance as required by applicable law.

6. This Ordinance shall take effect pursuant to applicable law.

ORDINANCE 0.2132-2021

EXPLANATION: An Ordinance adopting the Route 1 and Thomas Place Redevelopment Plan in the Township, pursuant to the Local Redevelopment and Housing Law, *N.J.S.A.* 40A:12A-1, *et seq*.

WHEREAS, the Local Redevelopment and Housing Law, *N.J.S.A.* 40A:12A-1 *et seq.*, as amended and supplemented (the "**Redevelopment Law**"), authorizes a municipality to determine whether certain property within the municipality constitutes an area in need of redevelopment; and

WHEREAS, to make such a determination under the Redevelopment Law, the municipal council (the "Municipal Council") of the Township of Edison (the "Township"), by way of Resolution R. 614-112020 adopted November 9, 2020, authorized and directed the planning board of the Township (the "Planning Board") to conduct a preliminary investigation of the property identified as Block 692.D, Lots 30.A, 31, 32, 33, 34, 35, 36, 37, 38, 39.A, and 40.B (certain properties fronting U.S. Route 1 and Thomas Place) on the Township's tax maps (the "Study Area"), and to determine that the Study Area meets the criteria for a Non-Condemnation Redevelopment Area, pursuant to Sections 5 and 6 of the Redevelopment Law; and

WHEREAS, on February 17, 2021, the Planning Board, after providing due notice, conducted a public hearing in accordance with the Redevelopment Law, at which hearing it determined that the Study Area qualified as an area in need of redevelopment and recommended that the Municipal Council designate the Study Area as an area in need of redevelopment pursuant to the criteria and requirements of the Redevelopment Law; and

WHEREAS, on April 14, 2021, the Municipal Council considered the Planning Board's recommendation and adopted Resolution R.192-042021, designating the Study Area as an area in need of redevelopment (non-condemnation) (the Study Area hereinafter referred to as the "Redevelopment Area"); and

WHEREAS, by commission of the Municipal Council, Bignell Planning Consultants, Inc. prepared a redevelopment plan for the Redevelopment Area entitled the "Route 1 and Thomas Place Redevelopment Plan" (the "**Redevelopment Plan**"); and
