RESOLUTION R.001-012022

AUTHORIZING THE ADOPTION OF A CASH MANAGEMENT PLAN FOR THE TOWNSHIP OF EDISON

WHEREAS, Chapter 148 of the Public Laws of 1997 requires the Governing Body to adopt an annual Cash Management Plan; and

WHEREAS, the following banks are authorized depositories for Municipal Funds consistent with the Governmental Unit Depository Protection Act and may be used by the Chief Financial Officer for the deposit of Township funds:

TD Bank - North Edison, NJ Bank of New York/Chase, National Community Division, Edison, NJ Capital One Bank/North Fork Bank, Edison, NJ Provident Bank, Edison, NJ PNC Bank, Edison, NJ Bank of America, Edison, NJ Columbia Savings Bank, Edison, NJ Metuchen Savings Bank, Metuchen, NJ Ocean First Bank, Monroe, NJ Valley National Bank, So. Plainfield, NJ Investor's Savings Bank, Edison, NJ State of New Jersey, Cash Management Fund U.S. Bank, Morristown, NJ Fulton Bank of NJ, Edison, NJ Unity Bank, Edison, NJ Indus American Bank, Iselin, NJ J.P. Morgan Chase Bank

,and

WHEREAS, the Chief Financial Officer is directed to use this cash management plan as a guide in depositing and investing the funds of the Township of Edison, and

WHEREAS, the following investments are permitted for use by the Chief Financial Officer:

- 1. Interest bearing bank accounts and certificates of deposit in authorized banks for deposit of local unit funds.
- 2. Government money market mutual funds that comply with N.J.S.A. 40A:5-15.1 (e).
- 3. Any federal agency or instrumentality obligation authorized by Congress that matures within 397 days from the date of purchase, and has a fixed rate of interest not dependent on any index or external factors.
- 4. Bonds or other obligations of the local unit or school district of which the local unit is a part.
- 5. Any other obligations with maturities not exceeding 397 days, as permitted by the Division of Investments of the Department of the Treasury for investment by local units.
- 6. Local government investment pools which comply with N.J.S.A. 40A:5-15.1 (e) and conditions set by the Division of Local Government Services.
- 7. New Jersey State Cash Management Fund.

8. Repurchase agreements of fully collateralized securities, which comply with N.J.S.A. 40A:5-15 (a).

WHEREAS, the priority of investment policies shall be, in order of descending importance: security, liquidity, and yield with funds managed to meet the Township of Edison's cash flow needs.

NOW, THEREFORE, IT IS RESOLVED by the Council of the Township of Edison, Middlesex County, New Jersey that the foregoing shall serve as the cash management plan of the Township of Edison for the year 2022.

EXPLANATION: A Resolution authorizing the re-appointment of various Township professionals until January 31, 2022.

WHEREAS, the Municipal Council ("Municipal Council") of the Township of Edison ("Township") has determined that it is in its best interests and those of Township residents to engage qualified professional consultants, and the Township is authorized pursuant to the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq. ("Local Contracts Law") to contract for "professional services" as it may require; and

WHEREAS, on January 6, 2021, the Municipal Council adopted resolutions authorizing the award of professional services contracts to the following:

WHEREAS, the Professionals Services Contracts each expire December 31, 2021; and

WHEREAS, the Local Contracts Law, more specifically *N.J.S.A.* 40A:11-5, allows for the awarding of a contract for "professional services" without public advertising for bids, and said professional services are essential to the ongoing function of Township operations; and

WHEREAS, for these reasons, the Municipal Council desires to extend each of the Professional Services Contracts until January 31, 2022, at the rates set forth in each agreement and the resolution of the Municipal Council authorizing same; and

NOW, THEREFORE, BE IT RESOLVED by the Municipal Council of the Township of Edison, County of Middlesex, State of New Jersey, as follows:

- 1. The Professional Services Contracts are hereby extended until January 31, 2022, at the rates set forth in each agreement and the resolution of the Municipal Council authorizing same.
- 2. A certificate showing the availability of funds for the extension of the Professional Services Contracts authorized hereby has been provided by the Chief Financial Officer of the Township and is made a part hereof indicating that the appropriation for the within expenditure is charged to the applicable accounts and is contingent upon the adoption of a temporary and/or permanent budget for the 2022 calendar year.
- 3. The Mayor of the Township may, upon ten (10) days written notice, and without cause, terminate any of the Professional Services Contracts.
- 4. This Resolution shall take effect immediately.

RESOLUTION R.006-012022

Explanation: This Resolution authorizes the settlement of litigation with Rotimi Owoh, Esq., on behalf of the African American Data & Research Institute, arising under the Open Public Records Act.

WHEREAS, in February of 2020, Rotimi Owoh, Esq., on behalf of the African American Data & Research Institute, had filed certain litigation against the Township of Edison ("Township"), with respect to his request under the Open Public Records Act ("OPRA") for certain government records pertaining to access to the eCDR and ATS/ACS computerized systems within the Township Police Department, which litigation was brought before the New Jersey Government Records Council ("GRC"), and captioned *Rotimi Owoh, Esq., on behalf of the African American Data & Research Institute, v. Edison Township Police Department (Middlesex)*, Docket No. 2020-55 (the "Litigation"); and

WHEREAS, following the filing of the Litigation and pursuant to Interim Order of the GRC, the parties were able to reach amicable resolution of the Litigation, including the production of the records sought by Mr. Owoh in the Litigation, and the payment of attorney's fees and costs in the amount of \$2,750.00; and

WHEREAS, the Township, in consideration of the forgoing and the attendant cost and expense of continuing the Litigation, is desirous of authorizing the settlement and compromise of the same, including the authorization of the payment of \$2,750.00 for attorney's fees and costs, all as aforesaid.

NOW, THEREFORE, BE IT RESOLVED by the Municipal Council of the Township of Edison, County of Middlesex, State of New Jersey, as follows:

- 1. The aforementioned recitals are incorporated herein as though fully set forth at length.
- 2. The settlement of the Litigation for the sum of \$2,750.00, be and hereby is approved, and the appropriate Township personnel be and are hereby authorized and directed to process such payment to legal counsel for the African American Data & Research Institute, Rotimi Owoh, Esq., in accordance with such invoice, purchase order, W-9 and other information provided or which may be provided in connection with the resolution thereof. All appropriate Township personnel are also hereby authorized and directed to execute any such documents as may be reasonably necessary to effectuate the terms of the settlement, including as necessary the execution of any settlement agreement or waiver and release, in such form as may be approved by Township Administration in consultation with the Township Attorney.
- 3. This Resolution shall take effect immediately.
