1.CASE# Z19-2023, SIVAKUMAR MUTHUSAMY, 5 ALZALEA DR

Applicant is proposing to extend a first floor addition and construct a second floor addition to the rear of the existing single family dwelling. **The following standards have not been met:** Max building coverage permitted is 20%, proposed is 26.6%. Max FAR permitted is 37%, Proposed is 48.47%. Affected property is located in the **R-BB Zone**, designated as Block # 1222, Lot #13 n the Edison Township tax map. All noticing paperwork is in order.

2. CASE# Z09-2021, KRISHNA ADULT DAY CARE, LLC 1691 Oak Tree Rd,

Applicant is proposing Preliminary and Final Site plan approval to utilize portion of building for an Adult Daycare. **Standards have not been met in accordance with the Master Plan.** Max imperious coverage required is 65% proposed is 77.4% Affected property is located in the **RRRD Zone**, designated as Block# 643.30, LOT# 19.06 on the Edison Township tax map. All noticing paperwork is in order.

3. CASE# Z04-2023, GARDEN STATE BUILDINGS, LP. DOCK RD

Applicant is proposing Preliminary and Final Site plan approval to construct additional, separate area for container storage and staging. **Standards have not been met in accordance with the Master Plan.** The proposed use is not permitted in this zone. Affected property is located in the **RRRD Zone**, designated as Block # 395, Lot #37 on the Edison Township tax map. All noticing paperwork is in order.
