# **ORDINANCE O. 2194-2023**

# AN ORDINANCE AMENDING AND SUPPLEMENTING THE CODE OF THE TOWNSHIP OF EDISON AND ESTABLISHING THE POSITION OF PUBLIC ADVOCATE

**BE IT ORDAINED,** by the Township Council of the Township of Edison that the Code of the Township of Edison is hereby amended and supplemented as follows:

- a. There is hereby established the position of Public Advocate. The Public Advocate shall represent the interests of residents of this Township in land use hearings before the Zoning Board of Adjustment and the Planning Board ("land use boards") in matters in which, if a development application was approved, there would be, in the judgment of the Public Advocate, a likelihood of a detrimental impact on the health, safety, quality of life or property values of residents, subject to paragraph g., below.
- b. In order to assert the interest of residents in land use board hearings, the Public Advocate is empowered to retain the services of experts to assist in evaluating development applications and to provide expert testimony at land use hearings.
- c. The Public Advocate shall be a member of the New Jersey bar, selected by the Township Council for a one-year term, who is knowledgeable in New Jersey land use law. The Township Council shall select one or more attorneys to serve as an alternate Public Advocate in matters in which the Public Advocate is precluded from participating in a land use matter because of a conflict of interest. The Township Council shall select a Public Advocate within 90 days of the passage of this ordinance.
- d. To assist the Public Advocate in evaluating whether a development application should trigger Public Advocate representation, there shall be a Residents' Advisory Committee. Initially, the Committee shall consist of five public members of the Council's public advocate study committee, plus an alternate member designated by the five initial members of the Committee. Within 180 days of the passage of this ordinance, an additional two members and two alternate members shall be designated in such manner as the Residents' Advisory

Committee may determine, subject to the consent of the Council. Terms shall be for three years expiring on June 30, except that certain initial terms shall be for shorter periods such that, as nearly as possible, one third of the terms shall expire each year. A member of the Committee whose term has expired may continue to serve on a holdover basis. A vacancy shall be filled by an alternate member as determined by the remaining members of the Committee. The Committee shall designate one of its members to serve as secretary of the Committee.

- e. If a land use board renders a decision that, in the judgment of the Public Advocate, is 1) detrimental to the health, safety, quality of life or property values of residents, and 2) legally flawed, the Public Advocate is empowered to appeal such decision to an administrative agency, if applicable, or, in the case of a use variance, to the Township Council, or, in any appropriate case, to a court of competent jurisdiction.
- f. Each land use board shall provide the Public Advocate and each member of the Residents' Advisory Committee, on a timely basis, with a digital copy of each development application submitted to such board. For each such development application, the secretary of the Committee shall record the opinion of each member of the Committee as to whether the proposed development is or is not likely to result in a detrimental impact on the health, safety, quality of life or property values of residents; and the secretary shall transmit those opinions to the Public Advocate.
- g. The Public Advocate shall not intervene in any matter which, in the opinion of a majority of the full members of the Residents' Advisory Committee, is not likely to have a detrimental impact on the health, safety, quality of life or property values of residents.
- h. The initial appropriation for the remaining portion of Fiscal Year 2023 shall be \$25,000. Thereafter, the Mayor and Township Council shall allocate sufficient funds to enable to Public Advocate to adequately and effectively represent the interests of the residents. The Public Advocate shall submit to the Department of Law, on not less than a monthly basis, invoices for work performed by the Public Advocate and by professionals retained by the Public Advocate.

**BE IT FURTHER ORDAINED** that this ordinance shall take effect following adoption and approval in a time and manner prescribed by law.

WHEREAS, on September 7, 2022, the State of New Jersey Planning Commission, under the Office of Planning Advocacy, adopted guidelines and recommendations pertaining to warehouse development to facilitate greater cooperation and coordination among local governments, their counties, and their regions titled "Distribution Warehousing and Goods Movement Guidelines" (hereinafter referred to as "State Warehouse Guidelines"); and

**WHEREAS,** the State Warehouse Guidelines states "Given the scale and intensity of new and emerging warehousing trends and building types, zoning that simply permits generic warehousing may not be sufficient to address the different types of warehousing uses...;" and

**WHEREAS,** the State Warehouse Guidelines also recommends "Zoning should evolve to keep up with the changing variety of uses and trends (including definitions) as the differences could mean dramatically different impacts and outcomes, and whether a project is compatible with a site and beneficial to a community;" and

**WHEREAS,** pursuant to <u>N.J.S.A.</u> 40:55D-68 and §37-66.3 of the Township Code, nonconforming uses as established by any new zoning ordinance shall be permitted to remain in operation and in use, subject to the conditions as established in each respective legislation; and

**WHEREAS**, the Township has a desire in establishing zoning guidelines which promotes for the public health and general welfare of the municipality; and

**WHEREAS,** the Township desires to amend the following subsections of Chapter 37, "Zoning," to add certain definitions to clarify types of proposed uses that warehouse structures may be classified as and to identify certain category of warehouses to promote for the general welfare of Township residents:

- §37-3.1, Word Usage, "Definitions"
- §37-32.2, R-I-1, Restricted Industrial District, "Permitted Uses"

- §37-33.1, L-I, Light Industrial District, "Permitted Uses"
- §37-33.8, L-I, Light Industrial District, "Prohibited Uses"
- §37-38.1, RRRD, Raritan River Revitalization District, "Permitted Uses;" and
- §37-38.8, RRRD, Raritan River Revitalization District, "Prohibited Uses."

**WHEREAS,** prior to the Municipal Council hearing on the adoption of this Ordinance, it shall be referred to the Township Planning Board as required under the Municipal Land Use Law pursuant to N.J.S.A. 40:55D-26 and N.J.S.A. 40:55D-64; and

**NOW, THEREFORE, BE IT ORDAINED,** by the Municipal Council of the Township of Edison, in the County of Middlesex, State of New Jersey amend Chapter 37, "Zoning" of the Code as follows:

# RESOLUTION AUTHORIZING THE SUBMISSION OF AN APPLICATION TO THE NEW JERSEY DEPARTMENT OF TRANSPORTATION'S SAFE ROUTES TO SCHOOL PROGRAM

**WHEREAS,** the FY2024 Safe Routes to School Program ("Program") provides federal funds for infrastructure projects that facilitate walking and/or bicycling to school, including the construction or installation of sidewalks, crosswalks, signals, traffic-calming measures, and bicycle facilities; and

**WHEREAS**, the FY2024 Program is being administered by the New Jersey Department of Transportation; and

WHEREAS, no municipal matching funds are required through this Program; and

**WHEREAS**, the Township of Edison wishes to apply for these grant funds in an amount not to exceed \$2,000,000.00 for the Edison Township School Intersections Improvement Project;

#### NOW, THEREFORE, BE IT RESOLVED, by the Township of Edison Council as follows:

- A. The Mayor and Council of the Township of Edison, in the County of Middlesex, State of New Jersey, formally authorize the Mayor and Clerk to submit an electronic grant application identified as "SRS-2024-Edison Township School Intersections Improvement Project-00029" to the New Jersey Department of Transportation for funding under the Safe Routes to School Program on behalf of the Township of Edison.
- B. This project involves roadways that are owned and maintained by the Township of Edison and by the County of Middlesex. The County of Middlesex will submit a letter of support stating that the Township of Edison is authorized to complete the proposed improvements along roadways owned and maintained by the County.
- C. Following the completion of the proposed project, the Township of Edison certifies that it will assume maintenance responsibility over all improvements completed with grant funding awarded under the FY2024 Safe Routes to School Program.
- D. The Township of Edison is designating Brian Piccirillo, Township Engineer as the responsible charge for this program. Brian Piccirillo is a full-time employee of the Township of Edison in the role of Design Engineer and will be the responsible charge for the proposed Federal-aid construction project.
- E. Upon receipt of a grant award, the Mayor, or those in said title, is hereby authorized to sign the grant agreement on behalf of Edison Township and that their signature constitutes acceptance of the terms and conditions of the grant agreement and approves the execution of the grant agreement.
- F. This resolution shall take effect immediately upon passage.

#### **RESOLUTION R.659-112023**

RESOLUTION AUTHORIZING AND DIRECTING THE PLANNING BOARD OF THE TOWNSHIP OF EDISON TO CONDUCT A PRELIMINARY INVESTIGATION TO DETERMINE WHETHER THE PROPOSED STUDY AREA, WHICH INCLUDES THE PROPERTIES IDENTIFIED ON THE OFFICIAL TAX MAPS OF THE TOWNSHIP AS BLOCK 340, LOTS 1.02, 1.30, and 2.01 (A/K/A 41 GLENDALE AVENUE) QUALIFY AS A CONDEMNATION AREA IN NEED OF REDEVELOPMENT IN ACCORDANCE WITH THE LOCAL REDEVELOPMENT AND HOUSING LAW, N.J.S.A. 40A:12A-1 ET. SEQ.

**WHEREAS**, the Local Redevelopment and Housing Law, <u>N.J.S.A.</u> 40A:12A-1 et seq. (the "**Redevelopment Law**"), authorizes municipalities to determine whether certain parcels of land in the municipality constitute areas in need of redevelopment; and

WHEREAS, to determine whether certain parcels of land constitute areas in need of redevelopment under the Redevelopment Law the municipal council ("Municipal Council") of the Township of Edison (the "Township") must authorize the planning board of the Township (the "Planning Board") to conduct a preliminary investigation of the area and make recommendations to the Municipal Council; and

WHEREAS, the Municipal Council believes it is in the best interest of the Township that an investigation occur with respect to certain parcels within the Township and therefore authorizes and directs the Planning Board to conduct an investigation of the properties commonly known on the Official Tax Maps of the Township as Block 340, Lots 1.02, 1.30, and 2.01 (a/k/a 41 Glendale Avenue) (hereinafter the "Condemnation Study Area"), to determine whether the Condemnation Study Area meets the criteria set forth in the Redevelopment Law, specifically N.J.S.A. 40A:12A-5, and should be designated as a condemnation area in need of redevelopment with the powers of eminent domain; and

WHEREAS, the redevelopment area determination requested hereunder authorizes the Township and Municipal Council to use all those powers provided by the Redevelopment Law for use in a redevelopment area, including the power of eminent domain (hereinafter referred to as a "Condemnation Redevelopment Area").

# NOW THEREFORE, BE IT RESOLVED BY THE MUNICIPAL COUNCIL OF THE TOWNSHIP OF EDISON, NEW JERSEY AS FOLLOWS:

- **Section 1.** The foregoing recitals are incorporated herein as if set forth in full.
- **Section 2.** The Planning Board is hereby authorized and directed to conduct an investigation pursuant to N.J.S.A. 40A:12A-6 to determine whether the Study Area satisfies the criteria set forth in N.J.S.A. 40A:12A-5 to be designated as a condemnation area in need of redevelopment.
- **Section 3.** As part of its investigation, the Planning Board shall prepare a map showing the boundaries of the Study Area and the location of the parcel contained therein and appended thereto shall be a statement setting forth the basis of the investigation.
- **Section 4.** The Planning Board shall conduct a public hearing in accordance with the Redevelopment Law, specifically N.J.S.A. 40A:12A-6, after giving due notice of (i) the proposed boundaries of the Condemnation Study Area and stating that a map has been prepared and can be inspected at the Township clerk's office and (ii) the date of the hearing to any persons who are interested in or would be affected by a determination that the Condemnation Study Area is an area in need of redevelopment. The notice of the hearing shall specifically state that the redevelopment area determination shall authorize the Township or Municipal Council to exercise the power of eminent domain to acquire any property in the delineated area, for the Condemnation Study Area is being investigated as a Condemnation Redevelopment Area.

- **Section 5.** At the public hearing, the Planning Board shall hear from all persons who are interested in or would be affected by a determination that the Condemnation Study Area is an area in need of redevelopment. All objections to a determination that the Condemnation Study Area is an area in need of redevelopment and evidence in support of those objections shall be received and considered by the Planning Board and made part of the public record.
- **Section 6.** After conducting its investigation, preparing a map of the Condemnation Study Area, and conducting a public hearing at which all objections to the designation are received and considered, the Planning Board shall make a recommendation to the Municipal Council as to whether the Municipal Council should designate all or some of the Condemnation Study Area as a condemnation area in need of redevelopment.
- **Section 7.** The designation of all or some of the Condemnation Study Area as an area in need of redevelopment, if such designation is made, shall authorize the Township and Municipal Council to use all those powers provided by the Redevelopment Law for use in a redevelopment area, including the power of eminent domain.
  - **Section 8.** This Resolution shall take effect immediately.
